MARCH 23, 2005

(Meeting Held at Redington Beach Town Hall)

President Taber called the March 23, 2005 BIG-C meeting to order at 9:00 a.m.

1. **Pledge of Allegiance:** President Taber let the assemblage in the Pledge of Allegiance.
2. **President Taber:** President Taber read former Belleair Beach Mayor Mike Kelly's letter of resignation (dated March 9, 2005) as President of the BIG-C. President Taber then presented a plaque of appreciation to former President / Mayor Kelly for his service as BIG-C President for 2004 – 2005.
3. **Roll Call:** Each person was asked to introduce him / herself.

President Taber gave "thanks" to Kathryn Cormier for catering "...a wonderful breakfast" for the members and guests of the BIG-C.

4. **Approval of Agenda:** There were no changes to the Agenda that was published and distributed.

5. **Approval of Minutes of February 23, 2005 Meeting; and,**

Approval of March, 2005 Treasurer's Report

Secretary-Treasurer Fontaine presented the February 23, 2005 Meeting Minutes and the March, 2005 Treasurer's Report (showing a balance of **\$2,769.98** as of March 8, 2005).

A Motion was made and seconded to approve the Minutes of February 23, 2005 and the March, 2005 Treasurer's Report. All showed their favor by voice vote.

7. **Guest Speaker: Honorable Ronnie Duncan, Pinellas County Commissioner**

President Taber introduced **Ronnie Duncan**, Commissioner, Pinellas County Board of County Commissioners. Commissioner Duncan addressed the members and assembled guests, and stated:

- ✓ He is a "rookie" commissioner; he wants to "listen and learn" and be a part of the process of the BIG-C
 - ✓ Mentioned J.J. Beyrouti as his campaign opponent and that they are now friends and he's got a great deal of respect for the Mayor and the work he's done with the BIG-C and throughout the Beach communities
 - ✓ Spoke of "common goals and objectives throughout Pinellas County"; thanked "all elected people who are present for their time, service and dedication to their communities and the larger community"
 - ✓ "Shared" the following:
 - A. Thanked Kathryn Cormier and said that "the County needs to hire her to cater some of their functions"; and,
 - B. Spoke of his "Grandmother's Cart with a Wobbly Wheel" – noting that Pinellas County is "out of balance" and is "wobbly".
 - ✓ Said he believes that:
 - A. The County "needs to make Gulf Boulevard a PRIORITY project in Pinellas County from the following perspectives: 1) Architecturally; 2) Safety; 3) Transportation, and 4) Stormwater Management – make Gulf Blvd. "a true corridor".
 - Step 1: County and Beach Communities agree on a (comprehensive) plan
 - Step 2: Figure out a way to pay for it
- Noted that at a recent County Board Visioning Meeting Commissioners **Bob Stewart**, **John Morroni**, **Karen Seel**, and **himself** all said they "...want to bring the Gulf Boulevard issue back to the table and make it a PRIORITY issue." And, also believes that:
- B. County leaders have to build "bridges of trust" – there's a lack of trust in Pinellas County. Noted that "building trust" means working together and "trying to keep the lawyers out of the process".
- After closing, several members addressed Commissioner Duncan:
- Mayor J.J. Beyrouti:**
Apologized for arriving late; said he "likes what I've heard (from Commissioner Duncan)"; but, there is a "need for new leadership at the County level" and there is a "need to change the trend vis-à-vis relating to the BIG-C and the Beach communities – less of an 'individual approach' by Commissioners and more of a concerted effort by the entire B.O.C.C."
- Mayor Fontaine:**
Made remarks re: "lobbying of smaller communities on behalf of big Cities like St. Petersburg"
- Mayor Robertson:** "Primary role of BIG-C is to speak with one voice; there is seemingly no coordination at County level when Beach projects are undertaken and a lack of coordination when there are several simultaneous County-sponsored projects going on at the same time"
- Mayor Taber:**
Said he recently "met with County and FDOT officials re: coordinating a project in Indian Shores along Gulf Blvd. – his City had to initiate the coordination between the two outside agencies.
- James Palmara** and other audience members spoke to Commissioner Duncan about concerns that they had.
