4. RESOLUTION NO. 2016-02. SUPPORTING WATERBORNE TRANSPORTATION THROUGHOUT THE BARRIER ISLANDS OF PINELLAS COUNTY.

#### 5. APPROVAL OF THE JUNE 29, 2016 MINUTES.

As explained by the St. Pete Beach City Clerk, the minutes are not ready.

#### 6. APPROVAL OF TREASURER'S REPORTS:

The reports were postponed until the next meeting.

#### 7. NEW BUSINESS:

A. Guest Speaker: Bob Dillinger, Public Defender, Sixth Judicial Circuit.

Mr. Dillinger provided a brief background, goals, and mission of Nourish to Flourish Program, explaining the program helps feed hungry Pinellas County elementary students on the weekends. Mr. Dillinger exhibited the 12-item tray of food that is handed out on Fridays to the students.

Mr. Dilinger explained the ways to contribute, and indicated he would like to speak to any organization that could help with this endeavor.

#### b. PCCLB Member Nominations 2016-2018.

President Hamilton-Wollin stated the BIG-C's appointment to the PCCLB will expire, and inquired if there were any nominations.

Vice Mayor Finnerty nominated St. Pete Beach Building Official Bruce Cooper to the PCCLB.

MOTION MADE BY VICE MAYOR FINNERTY, SECONDED BY MAYOR QUEEN, TO REAPPOINT ST. PETE BEACH BUILDING OFFICIAL BRUCE COOPER TO THE PCCLB AS THE BIG-C'S REPRESENTATIVE. UNANIMOUS APPROVAL BY ACCLAMATION.

#### 8. CORRESPONDENCE:

#### PENNY FOR PINELLAS

Commissioner Kennedy explained the current tax would expire December 31, 2019, and the BIG-C should request a renewal and negotiate an interlocal agreement to be finalized by September 2017.

Commissioner Kennedy volunteered to continue to represent the BIG-C in this matter. She also suggested that the BIG-C appoint a new committee to move forward with the process. She explained if the tax passes in 2019, the BIG-C interlocal agreement would be in place to once again appropriate monies for the Gulf Boulevard Beautification Project.

Jackie Trainer, Pinellas County, stated the current \$35 million would not expire on December 31, 2019, explaining that money was locked in. The Penny is up for renewal on December 31, 2019. The County would like to start discussing ideas for the next Penny money.

The discussion continued regarding current projects that have been started as well as those projects that have not. All projects must be started by the new vote date for municipalities to keep their funding.

Vice President Palladeno requested the subject of the renewal of the Penny for Pinellas Program be added to the next agenda.

#### 9. COMMITTEES:

#### a. BY-LAWS COMMITTEE.

Vice President Palladeno stated the committee will be recommending that roll call votes will be required for adoption of resolutions. He stated the committee will be bringing this to the board for consideration.

#### b. AUDIT COMMITTEE.

Mayor Queen stated the committee reviewed the reports and bank statement and found them to be in good shape.

#### c. GULF BOULEVARD BEAUTIFICATION COMMITTEE.

President Hamilton-Wollin explained that this item has been discussed; however, there has been a request to appoint a new committee for future issues. Mayor Simons requested a special review of the three Redingtons' projects by someone other than the three representatives from the three Redingtons' municipalities. Councilmember Hamilton and Vice Mayor Collins agreed to do the review.

#### 10. MISCELLANEOUS:

#### a. ADMINISTRATION OF OATH OF OFFICE.

President Hamilton-Wollin administered the oath of office to Mayor Notaro for secretary-treasurer of the BIG-C.
