## 3. Approval of Agenda

Mayor Notaro stated she would like to add newly appointed Pinellas County Emergency Management Director Cathie Perkins to the agenda so that she may introduce herself to the Council.

Motion was made by Mayor Queen to approve the October 31, 2018, BIG C Meeting Agenda to add Ms. Perkins. The motion was duly seconded and carried unanimously.

#### 4. Approval of Minutes

Motion was made by Mayor Queen to approve the September 26, 2018, BIG C minutes. The motion was duly seconded and carried unanimously.

# 5. Approval of September 2018 Treasurer's Report

Mayor Alan Johnson presented the September 2018 Treasurer's Report, stating there had been no activity.

Mayor Queen requested approval from Council of \$117.00 for payment of the plaque presented the prior week to outgoing County Administrator Mark Woodard at his retirement party.

Motion was made, duly seconded, and unanimously approved for payment of \$117.00.

Motion was made by Mayor Kennedy to approve the September 2018 Treasurer's Report. The motion was duly seconded and carried unanimously.

Mayor Notaro introduced Cathie Perkins. Ms. Perkins gave a brief overview of her experience and history, and stated she is "very happy to be part of the Pinellas County family", as she has been vacationing in the area for years. She looks forward to coming out to learn about each community's risks and concerns to continue to coordinate and work together.

#### 6. Correspondence

Mayor Notaro advised that *Visit St. Pete/Clearwater* (VSPC) will pay the Florida Shore & Beach Preservation Association (FSBPA) BIG C BeachWatch Membership fee of \$6,000.00. Council expressed their appreciation for the *Visit St. Pete/Clearwater* organization's contribution.

- Lt. List: The increased enforcement of charter boats with unlicensed captains has been a "very large priority" in the last six to eight months. He advised that the best way for communities to help is to report any information they have to the USCG.
- Lt. List advised that Air Station Clearwater is a Training Center, which is why there are the number and frequency of training flights observed in this area.
- Consideration of the Tentative 2019 BIG C Meeting Schedule

Following discussion, motion was made, duly seconded, and unanimously approved to accept the tentative schedule as presented. [The Town of Indian Shores date of Dec 4 was corrected to reflect December 5 following the meeting, and a revised schedule was emailed to the BIG C mailing list]

Discussion of Undergrounding of Utilities on Gulf Boulevard

Mayor Soranno: After having had several meetings with former County Administrator Mark Woodard he believes it makes sense for the County to take over the project in the interest of "efficiency and economies of scale". The exact dollar number is not known yet; \$35MM has been allocated in Penny IV. The estimate as of today is \$38.2MM. The funding needed to complete the Town of Indian Shores (\$500K) and the City of Clearwater (\$750K) are still an open issue at this time. With the exception of those two projects, supporting the project as presented by the County makes sense.

Mayor Queen: We won't really know anything until we let the project move forward and get a binding estimate for the costs.

Mayor Soranno: After discussion with Brian Lowack of Pinellas County, funds may be available from other sources in addition to the Penny money – tourist development money, state money – so it should not be an issue. His concern is that there may be unknown costs once ground is broken and the project begins. It makes sense to do the project with the County.

Mayor Queen: The next step is for the BIG C to draft a resolution to the County.

Motion was made by Mayor Queen with proposed language for the resolution stating:

The Barrier Islands Governmental Council supports the undergrounding project of Gulf Boulevard as one consolidated project with Pinellas County acting as the project coordinator supplemented by representatives from each participating municipality. After the binding estimates are established all savings below the Penny IV funds will be distributed with \$500,000.00 to Indian Shores and \$750,000.00 to Clearwater for additional beautification projects.

Motion was seconded by Mayor Cretekos.

Following discussion of what funds would be available to Indian Shores and Clearwater at the completion of the project, what additional funds are able to be secured from other sources, that the intent of the resolution is to protect the interests of Indian Shores and Clearwater and to support the County's coordination of the project - the consensus was to amend the language to read:

After the binding estimates are established, the understanding is that Penny IV money will also be distributed with \$500,000.00 to Indian Shores and \$750,000.00 to Clearwater for additional beautification projects.

Motion was made by Mayor Queen and duly seconded for the amendment to the resolution as stated. Motion and second were carried unanimously.

The vote to approve the resolution as amended was carried unanimously.

Council thanked Mr. Lomack.
