ANNOUNCEMENT: President Don Taber announced that there would be a news conference at 11:00am at Ft. DeSoto. Ft. DeSoto was voted Number 1 in the Nation according to a press release.

3. APPROVAL OF THE MAY 25TH BIG-C AGENDA. President

Motion was made by Mayor John Robertson, seconded by Mayor Bob Fontaine to approve the May 25th agenda, carried unanimously by voice vote.

4. APPROVAL OF THE APRIL 7, 2005, BIG-C MINUTES. Motion was made by Mayor John Robertson, seconded by Mayor Bob Fontaine to approve the April 27, 2005, minutes, carried unanimously by voice vote.

5. APPROVAL OF MAY 2004 TREASURER'S REPORT. Treasurer Bob Fontaine read the Treasure Report to the council. Motion was made by Mayor John Robertson and seconded by Commissioner Richard Kraus to accept the May 2005 Treasurer's Report as read, carried unanimously by voice vote.

6. GUEST SPEAKER – DAVE MOORE, EXECUTIVE DIRECTOR, SOUTHWEST FLORIDA WATER MANAGEMENT DISTRICT (SWFWMD)

Dave Moore, Executive Director, Southwest Florida Water Management District (SWFWMD) was the guest speaker. He gave an update of the water supply in the State of Florida. He indicated that the water supply is meeting the needs of the Tampa Bay area. Our water supply is in good condition.

He attributed this to the use of reclaimed water and conservation. He said the water use today in 2005 is the same as it was in 1997 and 1998.

He said there is still research going on especially in desalination. Conserving water is a positive step in maintaining an adequate water supply.

At this time, there is not a water shortage.

**7. PRESENTATION BY ANGELO RAO, P.E., VOLKERT & ASSOCIATES,
REAGRNDING PEDESTRIAN-BICYCLE SAFETY**

Angelo Rao, Volkert & Associates, Inc., presented a power point presentation on Pedestrian Safety issues. He showed what is out there and what is working.

Among his presentation were the following:

Probability of Pedestrian Fatality with increasing speed. The faster a motorist drives, the more likely of a pedestrian fatality – we need to consider the speed in highly pedestrian areas.

There are many cities that consider their pedestrian first

The 5-minute walking rule which is a comfortable walking distance. If there are amenities within a 5-minute distance, people are more likely to walk the distance rather than drive.

Other pedestrian safety considerations are narrow roadways, mediums, colorize crossing lanes and changing some of the dynamics.

Mr. Rao showed different signage that can be used as safety factors – Of particular interest to the council was the Count Down Pedestrian Signal. Pedestrian would know how many seconds they had to cross at the lights. The other was the flashing speed indicator on the side of the road rather than the smart cart used in most areas. The cost of the Count down is in the area of \$400. The speed sign is about \$65,000.

He presented a number of pictures of the above mentioned safety factors that are in place in various neighboring communities.

For Gulf Boulevard, he feels the best solution is concentration – repetitiveness along Gulf Boulevard and neighbor friendly. Make the environment pleasing.

8. OLD BUSINESS:

A. Report from Mayor Bob Fontaine relative to Gulf Boulevard – “Speed Limit”

Mayor Bob Fountain said he met with MPO, FDOT and the Sheriff’s Department. They were all very supportive. With FDOT, he met with Ken Hartmann, Secretary of District 7, and his replacement Don Skeleton, and they were very supportive.

There was some discussion about lowering the speed limit. It was suggested that if motorists exceeded the speed limit by 5 miles that the law enforcement could give them a warning rather than ticketing them. The Sheriff’s Department indicated they would work with the communities in promoting safety.
