**7. New Business:**

- a. **Guest Speaker:** John Bennett, Assistant County Administrator.

Mr. Bennett distributed literature and reviewed the BOCC strategic plan for EMS services to the entire County.

- b. **Appointment** of Indian Rocks Beach City Commissioner Joanne "Cookie" Kennedy to Forward Pinellas as the Barrier Islands Governmental Council's representative.

President Terry Hamilton-Wollin advised that Commissioner Finnerty had withdrawn her name for consideration.

Motion was made and duly seconded to reappoint Joanne "Cookie" Kennedy, Commissioner of the City of Indian Rocks Beach, as the BIG-C representative to Forward Pinellas, serving as the Pinellas Planning Council and the Metropolitan Planning Organization, for a two-year term. Motion carried unanimously.

Discussion followed regarding the BIG-C committees.

Motion was made and duly seconded to reduce the BIG-C Penny for Pinellas subcommittee and the Holiday Beach Cleanup fact-finding committee to one-person committees with Mayor Minning sitting on the Holiday Beach Cleanup fact-finding committee and Mayor Palladeno sitting on the Penny for Pinellas subcommittee. Motion carried unanimously. No action was taken on the Gulf Boulevard Beautification Committee.

## **8. Old Business**

### **a. Nominations to the Pinellas County Construction and Licensing Board.**

Motion was made and duly seconded to nominate Frank DeSantis and Sprague Owings, in addition to Bruce Cooper, as the BIG-C representatives to the Pinellas County Construction and Licensing Board. Motion carried unanimously.

## **9. Legislative Updates.**

Representative Peters' office reported meetings regarding the recent sewer issues, and that Representative Peters would like to schedule meetings with each Mayor to discuss any appropriations requests.

Representative Ahern's office would be having a breakfast meeting with his constituents, if any would like to attend, and would also be asking cities for any appropriations requests.

Representative Jolly spoke regarding beach nourishment. He stated that he had asked the Army Corp of Engineers to do a walkthrough of the beaches post Hurricane Hermine and Hurricane Matthew to assess the deterioration and erosion, and they had agreed. The date for the next nourishment had not been determined.

**Belleair Beach:** Mayor Notaro announced the City-Wide Yard Sale.

**St. Pete Beach:** Mayor Schechner announced the City's Concert Series.

**Indian Shores:** Councilor Smith announced the December BIG-C meeting would be in Indian Shores.

**N. Redington Beach:** Mayor Queen stated all was quiet in North Redington Beach.

**Treasure Island:** Mayor Minning announced the Annual Sanding Ovations sand sculpting competition. He advised that they had also instituted a Gulf Boulevard Pedestrian Safety Program.


